

Non-Disclosure Agreement (NDA)

By checking the designated box on Atelier Steaven Richard's website, the user acknowledges that they have read, understood, and accepted this Non-Disclosure Agreement.

Parties

This Agreement is entered into between **Atelier Steaven Richard**, whose registered office is located at 27 rue de la Folie Méricourt, 75011 Paris, France, and whose correspondence address is 371 rue des Chênes, 77590 Chartrettes, France, hereinafter referred to as the "**Disclosing Party**", and any natural or legal person consulting, receiving, requesting, or using information, documents, samples, prototypes, or data provided by Atelier Steaven Richard, hereinafter referred to as the "**Receiving Party**."

Purpose of the Agreement

The Disclosing Party may disclose confidential information (including samples, prototypes, documents, technical data, know-how, manufacturing processes, etc.). The Receiving Party agrees to comply with the confidentiality obligations set forth below.

1. Definitions

1.1 "Confidential Information" means any information, data, documents, technical specifications, samples, or any other material communicated by the Disclosing Party, whether in written or physical form.

1.2 Samples provided under this Agreement shall also be considered Confidential Information.

2. Obligations of the Receiving Party

The Receiving Party agrees to:

- not disclose, reproduce, or communicate the Confidential Information without prior written authorization;
- use the Confidential Information solely for the purposes of study, evaluation, or collaboration with Atelier Steaven Richard;
- not perform any reverse engineering;
- not counterfeit, reproduce, or cause the reproduction of the samples or manufacturing processes;
- not develop or cause the development of competing products.

5. Remedies

5.2 A court injunction to prevent or stop any unauthorized use of the Confidential Information.

6. Governing Law

This Agreement shall be governed by the laws of France. Any dispute shall be subject to the exclusive jurisdiction of the courts of Paris.
